S.R.O.894 (I)/2006.- In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Federal Government is pleased to exempt the goods specified in column (3) of the Table below falling under the HS Code of the First Schedule to the said Act, as specified in column (2) of the said Table, to the extent of percentage of concession as specified in column (4) of that Table, on the import into Pakistan from Iran, if made in conformity with the Pakistan – Iran Preferential Trade Agreement Rules of Origin, 2004, as notified by the Ministry of Commerce under the Preferential Trade Agreement between the Islamic Republic of Pakistan and the Islamic Republic of Iran.
